

As far as HBSE textbooks go, this one blends sociology and social work better than others. It also has a decent index, which is very important for any student (online quizzes, finding quotes for papers, etc). Where it falls a little short is in its inconsistent style. Too many authors(cooks) spoiled the broth? I don't know. That might not be the root problem. But I really felt like different chapters were written, and even laid out, in ways that didn't coalesce with the rest of the book. Maybe there's some sort of meta-poststructuralist meaning behind it, but if that's not it, I'd say it was just a mistake.

With each chapter being more than 30 pages long, this book is a difficult read. As a reader I expected it to be a bit more interesting.
