

With the Revenue Act of 1916, which brought us the modern day income tax, also contained a tax on estates. The tax was levied to help finance World War I. However, unlike previous attempts at taxing estates, this time, it didn¢â ¬â,¢t go away when the war was over. In 1924, the Gift Tax was added. The Gift Tax was a tax on the transfer of assets from person to person. In 1976, there was a major overhaul of the Estate and Gift tax, which gave us the system we have today.
