

The font is large enough so that most can read it with little to no issue(s), and each page has more than enough information within it. The whole book itself is much thicker than I anticipated (which is good) and full of semi-updated information in terms of testing material. What I did not enjoy (although I was aware it was used to an extent) was the excessive markings within the book itself, spoiling every multiple choice answer I attempted to solve. Everything (and I mean e v e r y t h i n g), is already pre-circled, underlined, or crossed out by the book's previous owner(s) which makes it tough to study. Other than that, it was a solid purchase. Would recommend the book, but buy it new for your own sake. :)

There's an error in the book on page 240 #27. The answer is C and NOT D. Page 243 confirms what the correct answer should be. I almost marked my answer as incorrect. Overall, this book has excellent tips even if you are a natural test taker like myself and I noticed my score kept improving after each exam. Can't wait to ace the exam on Saturday.
