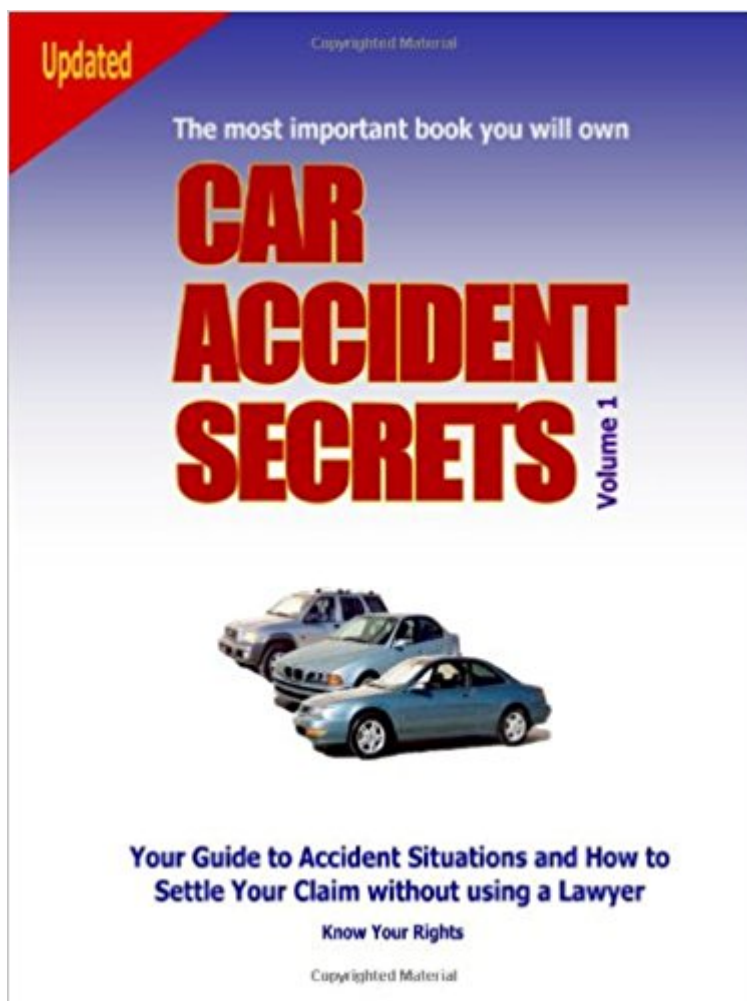

Why pay an lawyer \$5,000 of a \$15,000 settlement when you can do it yourself ? Don't hire that lawyer to handle your personal injury claim from an accident . Do it yourself and save the lawyers fee. Lawyers will typically take 1/3 of your settlement ! Can you afford to throw \$5000 away ?

This book contains real accidents and a step by step guide to each accident resolution. It also shows how the claim was collected and all the steps the author took to receive his claim without using a lawyer.

This book is great if you need basic quick knowledge on the subject. I purchased 3 books about car wrecks and personal injury. This one is a easy read and quick. I liked his formula which talks about the work you lost plus the cost of the accident plus pain and suffering. I don't know why he times it by 1-5. The only trouble is most car wrecks are difficult to nail down in cost and insurance adjusters have the upper hand on us. I don't know all the legal stuff adjusters know. But this book is helpful to those who need a quick know how of what to do in a fender bender accident. I wish it had more information in it. Price point wise. I don't think it's worth what amazing is asking for what you get. It

should be more around the range of six to eight dollars. Because the book is short and I felt like I read a well written pamphlet. I just wish it would have had more detail and situations. Every car accident is different every state has different laws. You usually get burned by adjusters and a lot depends on luck, timing specific details and how bad the accident really was.\* not part of the book my own 2 cents.If things are really bad at your car accident or if you get an adjuster that is mean and sneaky, get a lawyer. Not one you've seen on the T.V. ask doctors or your chiropractor or friends and family or anyone you know that has been in a car accident. Most people will point you to a good lawyer.I'm not a professional review writer. I probably made a thousand mistakes in this review. But I give it 4 stars out of 5.

The thin paperback book, "Car Accidents Secrets" provides general common sense instruction on how to handle a personal injury case by yourself. I found no illuminating secrets in this book and the information it does offer is easily accessible on a number of free web sites, ie. Pain and suffering calculator. I suggest the writer provide more real life detail, and offer examples how to negotiate your claim with an adjuster. An adjuster will state there is no magic P&S calculator. I would expect the author to anticipate this and advise the claimant how best to reply. Overall, the book offers a good general guide on how to settle a claim. Save yourself \$30 by clicking on a few internet lawyer based sites for the same general guidance offered in this book.

I was involved in an accident in January during a snowstorm. After one year of healing from my car accident, I finally settled with the other drivers insurance company on my own. I followed the book step by step, everything is listed in order for you to follow. I did;t have to go against my insurance policy, the book showed me that and many more hints which helped save me thousands of dollars from hiring a lawyer.I was also very pleased at how easy it was to read and follow along with the author given several examples of real accidents and how they were handled. There are things in this book you should do immediately even if a lawwyer is needed. The book has a chart to tell you and when it makes sense.There are more than one secret that everyone as a driver should know from the book that would help you in case you do have an accident. As someone who has used the book to settle, I can tell you I am very pleased for the price.

This book is rather helpful in a general informative manner especially for those who have not had to deal with an insurance adjuster or the process one goes through to file a claim. It's easy to follow and refer back to as you heal and recover. It however lacks detail in how to best determine and justify the pain and suffering aspect of the claim under its "Secret Formula" section. This may be something the author could clarify and enhance more thoroughly in his next volume/edition. It does stress keeping very good, detailed records including a daily diary which is rather helpful. If you have been in a minor or medium accident, this would be a good resource to have along with other resources including insights from your own auto insurance agent.

I got in an accident, someone hit me and caused about 800\$ of damage to my car. The car was towed to a garage and I needed a loaner. I wish I had bought the book before I got hit. I made 2 mistakes with the garage and the loaner car, if I had read the book it would have saved me even more money. Thank goodness I found the book on the internet after the accident. I used the book, the forms and the secret formula to get a great settlement from the "other" drivers insurance cpany. Before I read the book I thought my insurance company and me would have to pay for the damages I received. The book also includes a chart that shows based on an accident who pays for what. It also tells you how to talk to the other insurance company. Without the book I would have never received the amount I did.
