

I downloaded this book expecting to have to slog through dense, dry text so I could interview intelligently for a job. It's turned out to be far, far better than I expected. The ideas are clearly presented and thoughtfully laid out, the information is exactly what I was looking for but what surprised me was how well it was written. It's almost a story that pulls the reader along. I haven't had to re-read a sentence three times to untangle the meaning. That's rare in either water resource literature or law (even for non-lawyer) books. At the same time, I'm comfortable that I have an overview of the subject that I can build on. Thank you!

I was surprised by how clearly the author describes water law; the book is worth it for that alone. What I did not expect was Jones' thorough review of hydrology. This is an essential reference book for anyone who wants to understand Colorado water issues.

The book provides a useful summary for lawyers too, and gives a comprehensive introduction to complex groundwater rules. Highly recommended particularly for those conducting comparative research against Colorado.
