

This book has lots of good useful information on what to do if you or a loved one finds himself in trouble with the law. How to deal with the courts, lawyers, and jail is difficult, because the justice system is loathe to provide timely and adequate information once you are caught up in it. The prevailing attitude is that you must be guilty or you wouldn't have been arrested. This book arms you with the information you will need to have a fighting chance to clear yourself or your loved one. At the very least, it will help minimize the damage caused by the "system." One thing I didn't like was the insistence that military service will clear up all the problems of the defendant, should he tell the court that is what he intends to do, if the court will let him go. What makes the author believe the military is interested in a guy that can't keep out of trouble? Also, if you mess up in the military, the UCMJ is much more harsh, and much more unforgiving of "ignorance of the law" than the civilian side.

This book is written for families who must cope with the arrest of a family member. For anyone with a relative facing the local jail system and courts, this book is a necessity. It explains the criminal justice system from the street level view of the arrestee. It explains what to expect and how to deal with situations. There's a reoccurring cycle of arrest and recidivism and you should know why it happens. Families must know what to do protect themselves from viper lawyers, bail bondsmen and their loved one's own bad habits. Arrest and incarceration can financially and emotionally destroy families. Know how the system works and families can avoid financial costs and manipulation while getting the best legal outcome. The book is easy to read and is jammed with the useful information needed to navigate the system and protect your checkbook and sanity.

This is basically a how-to book. It tells you what you need to know from the time a loved one is arrested. Every family should buy this book. The author frequently writes articles in the Jacksonville Folio, a weekly magazine, on other important issues regarding the law. His style of writing is so clear, simple and candid, a 5th grader would come away with an understanding.
